PART A - WAIVER OF LIABILITY

BY SIGNING THIS DOCUMENT YOU WILL BE SURRENDERING CERTAIN LEGAL RIGHTS WHICH YOU HAVE, INCLUDING THE RIGHT TO SUE. PLEASE READ IT CAREFULLY.

I acknowledge that I am aware of the risks, dangers and hazards of the sport of ice hockey, contact or non-contact, including the possible risk of severe or fatal injury to myself or others.

The undersigned and their heirs, executors and personal representatives hereby release, forever discharge, indemnify and hold harmless River Cree Sports Limited Partnership, River Cree Sports Inc., their directors, officers, contractors, employees and their respective successors and assigns from any and all loss or damages that may result from any disease, deterioration of health, illness or injury to my person, including death, or the loss of any property resulting from and arising out of the use of the River Cree Twin Rinks facilities by me or from the negligence of River Cree Sports Limited Partnership, River Cree Sports Inc., and their directors, officers, employees, or other persons using the River Cree Twin Rinks, the use of these facilities being solely the responsibility of the parties using such facilities.

PART B - PARTICIPATION IN THE RIVER CREE HOCKEY LEAGUE (the "RCHL")

The undersigned (the "Participant") is advised to carry medical insurance. The Participant certifies that he / she has no known medical condition that would prohibit him/her from participating in the sport of ice hockey. The Participant agrees to reimburse the RCHL, in full within five days of notice, for the cost of any property damage for which the Participant is held responsible by the River Cree Sports LP staff or owners. The determination of such responsibility shall be binding on the Participant. The Participant agrees to the RCHL policy that there is no reimbursement to any Participant.

The RCHL Management has the final authority as to what divisions and times the Teams and Participants will play in. The Participant understands and agrees that he / she may be expelled from the RCHL for any of the following reasons:

- · Financial delinquency
- Failure to abide by RCHL rules
- Falsification of registration information.

PART C - HOCKEY CANADA INSURANCE POLICY

In conjunction with ASHL and the ASHN (Adult Safe Hockey Network), Hockey Canada (the broker, insurer, and underwriter), each person ("Participant") using the ice facilities at River Cree Sports and participating in the RCHL may receive Accidental Medical and Dental coverage as part of the ADULT SAFE HOCKEY NETWORK (ASHN) at no additional cost to the individual. In addition, RCHL (River Cree Sports), Aon Reed Stenhouse Inc. (the broker), and Sovereign General Insurance (the Insurer), each person ("Participant") using the ice facilities of River Cree Sports may receive Accidental Death and Dismemberment coverage as part of the RIVER CREE HOCKEY LEAGUE (RCHL) at no additional cost to the individual. To be eligible for insurance coverage, each Participant must complete the ACL Online Registration process at www.adultrechockey.ca and provide an accurate digital signature (or written signature below if not playing at a facility with digital signature). The information provided in this process may be used in registering each Participant with the insurance provider. Failure to complete this process in its entirety or providing any false or misleading information or

omitting any material information will nullify the participant from insurance coverage with the RCHL and its insurance carrier or may result in denial of coverage by the insurer.

All RCHL Participants are encouraged to request and review the current Accident Coverage Policy, available through the Facility and / or League Manager.

PART D - PAYMENT TERMS AND CONDITIONS

Team Entries: A minimum \$1,000.00 deposit must accompany your registration to be guaranteed a spot. The balance will be payable according to the payment terms of the River Cree Sports. It is the responsibility of each Participant in the RCHL to learn these payment terms by either attending Team Rep Meetings, held in advance of the season start date, or from his/her Team Rep. All late payment amounts are subject to a 14% (fourteen percent) interest charge calculated daily at (0.038356%). As of the FINAL PAYMENT DATE, River Cree Sports reserves the right to charge all outstanding amounts including interest charges to the credit card provided by the registrant. Post-dated cheques are not exempt from late fees. Talk to the league coordinator any alternative methods of late penalty fees. No refunds on deposits.

Individual Entries: Participant must pay 50% (fifty percent) of the required amount upon registration and the balance due prior to the first game. No refunds on deposits. Payments may be made by Debit Card, Visa, Master Card, Cash or Cheque. If the balance of the payment is not received on or prior to the first game, River Cree Sports reserves the right to bill all outstanding amounts to the credit card provided by the registrant.
